IMPLEMENTATION:

The Students' Grievance Policy is implemented through Policy manuals, college website portal and the Students' Grievance Redressal Cell constituted under IQAC, Jorhat KendriyaMahavidyalaya, Jorhat. The Cell comprises of a committee approved by the Governing body of the college. Grievances received from the students via online and offline medium are accepted on any working day by the concerned authority.

MONITORING:

The Students' Grievance Redressal Cell keeps a constant check on the grievance redressal mechanism. The cell organises an orientation programme at the beginning of every semester to explain the grievance mechanism to the students. The Cell checks the grievance box every 15 days for new complaints and forwards it to the authority for proper action.

ANTI-RAGGING POLICY

AIM

To root out ragging in all its forms from Jorhat Kendriya Mahavidyalaya by implementing anti-ragging measures and providing for strict punishments to be meted out to persons violating the Anti-Ragging Regulations of the College.

REFERENCE DRAWN

 a) Supreme Court Orders, b) Assam Government Act, and c) UGC Guidelines

WHAT IS RAGGING?

Ragging is defined by the Supreme Court of India as:

- Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other student, indulging in rowdy or undisciplined activities which causes or likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student.
- Asking the students to do any act or perform something which such student will not do in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.

Likewise, The Assam Prohibition of Ragging Act, 1999, enacted by the Assam Legislative Assembly defines Ragging as:

 Either display or noisy or disorderly conduct or doing of any act which causes or is likely to cause social, physical or psychological harm

- Raise apprehension or fear or shame or embarrassment to any student in any educational institution and includes teasing, abusing of, playing practical jokes on or causing hurt to, such students
- Asking the student to do any act or perform something which such student will not, in the ordinary course, willingly do

PROHIBITION OF RAGGING?

Ragging within the College Campus including Departments, Offices common areas, open spaces and hostels is strictly prohibited. Ragging in any form is prohibited inside or outside the campus

PUNISHMENT FOR RAGGING

Those found guilty for ragging (both involved directly or aiding ragging) will be liable for one or more of the following punishments depending upon the gravity of the offence

- Cancellation of admission
- Suspension from attending classes
- Withholding / withdrawing scholarship / fellowship and other henefits
- Debarring from appearing in any test/ examination / withholding results
- Debarring from representing the institution in any regional / national / international events / tournament / festival
- Permanent Expulsion from the hostel / institution.
- . A fine up to Rs. 10,000 (Rs. Ten thousand).

PREAMBLE:

Jorhat Kendriya Mahavidyalaya is dedicated towards building a community which provides a healthy environment which believes in gender equality and is free of any kind of violence, harassment, bullying, discrimination, or mishandling. This includes all forms of gender violence, sexual harassment, and discrimination based on gender. Every member is expected to be aware of the commitment to the right to freedom of expression and association, it strongly supports gender equality and opposes any form of gender discrimination and violence.

OBJECTIVES OF THE POLICY:

- To evolve a mechanism for the prevention and redressal of sexual harassment cases and other acts of gender-based violence in the institution.
- To ensure the implementation of the policy in letter and spirit through proper reporting of the complaints and their follow-up procedures.
- reporting of the complaints and their follow-up procedures.

 III. To provide an environment free of gender-based discrimination.
- To ensure equal access of all facilities and participation in activities of the college.
- To create a secure physical and social environment which will deter acts of sexual harassment.

DEFINITION OF SEXUAL HARASSMENT:

Sexual harassment includes unwelcome sexually determined behaviour (whether directly or by implication) as:

- Physical contact and advances;
- A demand or request for sexual favours;
- Sexually coloured remarks;
- Showing pornography;
- Any other unwelcome physical, verbal, or non-verbal conduct of sexual nature

Where any of these acts is committed in circumstances where-under the victim of such conduct has a reasonable apprehension that in relation to the victim's employment or enrolment in the institution whether she is drawing salary, or honorarium or otherwise, such conduct can be humiliating and may constitute a health and safety problem. It is discriminatory for instance when the woman has reasonable grounds to believe that her objection would disadvantage her in connection with her employment or work or studentship including recruiting or promotion or academics when it creates a hostile work environment. Adverse consequences might be visited if the victim does not consent to the conduct in question or raises any objection thereto.

JURISDICTION:

The rules and regulations outlined in this policy shall be applicable to all complaints

- By a member of the institution against any other member irrespective of whether the harassment is alleged to have taken place within or
- outside the campus.

 By an outsider against a member of the college or by a member of the college against an outsider if the sexual harassment is alleged to have taken place within the campus.
- By a member of the college against an outsider if the sexual harassment is alleged to have taken place outside the campus. In such cases the Committee shall recommend that the college authorities initiate action by making a complaint with the appropriate authority. Further, the committee will actively assist and provide available resources to the complainant in pursuing the complaint.

MEMBERS OF ANTI-SEXUAL HARASSMENT COMMITTEE:

- One chairperson or presiding officer.
- Two members amongst the employees.
 One external member- lawyer.

POWERS OF THE COMMITTEE.

- The Committee shall have the power to summon witnesses and call for documents or any information from any employee/student.
 If the Committee has reason to believe that an employee/student can furnish
- relevant documents or information, it may direct such person to produce such documents or information by serving a notice in writing on that person, summoning the person, or calling for such documents or information at such place and within such time as may be specified in the written notice.
- Where any relevant document or information is recorded or stored by means of a mechanical, electronic or other device, the Committee shall have the power to direct that the same be produced, or that a clear reproduction in writing of the same be produced.

 Upon production of documents / information called for by it, the Committee
- shall have the power to (i) make copies of such documents / information or extracts there from; or (ii) retain such documents / information for such period as may be deemed necessary for purposes of the proceedings before
- The Committee shall have the power to issue interim directions to / regarding
- any person participating in the proceedings before it.

 The Committee shall have the power to recommend the action to be taken against any person found guilty of (a) sexually harassing the complainant; (b) retaliating against / victimizing the complainant or any other person before it; and (c) making false charges of sexual harassment against the accused

FUNCTIONS OF THE COMMITTEE:

1. PREVENTIVE STEPS.

It will be the endeavour of the committee:

- 1. To facilitate a safe environment that is free of sexual harassment;
- To promote behaviours that create an atmosphere that ensures gender equality and equal opportunities

2. REMEDIAL STEPS.

- To ensure that the mechanism for registering complaints is safe, accessible and sensitive.
- To take cognizance of complaints about sexual harassment, conduct enquiries, aid and redressal to the victims, recommend penalties and take action against the harasser, if necessary.
- 3. To advise the competent authority to issue warnings or take the help of the law to stop the harasser, if the complainant consents.
- To seek medical, police and legal intervention with the consent of the complainant.
- To make arrangements for appropriate psychological, emotional and physical support (in form of counselling, security and other assistance) to the victim if so desires.



Mechanism to place Grievance:

- A Grievance Box is provided, where a student can drop his/her Grievance or Suggestion without any hesitation,
- E-Samadhan Box, an online complaint provision is also created to facilitate students to place their complaints.
- Moreover, a WhatsApp no. is made available by the Head of the Institution for the students for any kind of complaint.
- A written complaint can be given to the concerned authority.
- Moreover, The Head of the Institution takes feedback from students from time to time.

Procedure of addressing Grievance:

- The Head of the Institution tries to ensure fast addressing of grievances related to students' academic matters.
- All grievances other than academic matters, ragging cases and Sexual harassment cases are forwarded to the concerned committees for proper and thorough analysis.
- After proper analysis of evidence and other factors, the committees take decisions.
- The decisions taken by the Committee is forwarded to the Principal for enactment.

A combined sitting of the Disciplinary Committee and Anti-Sexual Harassment cell (GSCASH) was held on the 28th of November 2020. The meeting was chaired by the Principal of the College and Chairman of both the committees Dr. G.C Borah and was attended by seven members.

Agenda:

 To discuss the issue concerning Mr. Arnob Kalita (General Secretary of student's union) on the basis of a complaint lodged by Ms. Pratiksha Mahanta, consequent show-cause notice by the College authority to the accused and the latter's reply to the notice.

Proceeding:

The members discussed the issue in detail after having gone through the complaint letter by Ms. Pratiksha Mahanta signed by five witnesses, the show-cause notice by the authority to Mr. Arnob Kalita and his reply to the letter. In response to the show-cause notice, Mr. Arnob had admitted guilty of physically abusing Ms. Pratiksha and had begged for forgiveness.

Prior to the meeting, both students and their guardians were informed about the meeting and asked to be present at the College grounds and await their being summoned to the meeting hall. Neither Arnob Kalita nor his guardian turns up. Pratiksha Mahanta appears with her mother and both are summoned by turns to the meeting hall.

Pratiksha Mahanta speaks about the confrontation between her and Arnob Kalita. As reported by her, she was slapped, hit on the stomach and pushed against the wall on account of a personal issue. She also brings up the name of another student Ms. Shivangi (1st Semester) and says that she had called her up and requested that she withdraw the complaint letter. Pratiksha's mother is also heard. It becomes known that Pratiksha had confessed to her mother about her feelings towards Arnob prior to the confrontation and that both parents had spoken to Arnob and requested him to concentrate on his studies.

Adjournment

After discussions the members came to a decision that since Arnob Kalita and his parents did not appear that day and since a new name emerged to surface, resolutions could not be taken without hearing her out. Therefore, Arnob Kalita was asked for a second time to appear with a parent or guardian on the 1st of December 2020 at 1 PM. Shivangi was also asked to appear on the given date and time for her side of the story. The meeting was adjourned to the 1st of December 2020.
